

ORDINANCE NO. 761

AN ORDINANCE OF THE TOWN OF OGDEN DUNES,  
PORTER COUNTY, INDIANA REGULATING  
VEHICULAR TRAFFIC WITHIN THE TOWN.

WHEREAS, Indiana Code authorizes municipalities to impose restrictions on the operation of vehicles upon highways under their jurisdiction;

WHEREAS, the Town of Ogden Dunes Town Marshal and Street Superintendent have recommended the adoption of a vehicle weight restriction as contained in this Ordinance to promote the health, safety and public welfare of the residents of the Town of Ogden Dunes, and to prevent damage and the accelerated deterioration of the highways, roadways and streets of the Town; and,

WHEREAS, the Ogden Dunes Town Council has studied the matter and now concurs in the recommendation of its Street Superintendent.


NOW THEREFORE, BE IT AND IT IS HEREBY ORDAINED by the Town Council of the Town of Ogden Dunes, Porter County, Indiana, as follows:

1. No person shall operate any vehicle having a gross vehicle weight, in excess of twelve thousand (12,000) pounds on any highways, roadways or streets located north of the Northern Indiana Commuter Transportation District (NICTD) South Shore Line railroad right-of-way within the limits of the Town of Ogden Dunes, Indiana.
2. The restrictions contained herein shall also apply to any vehicles making local deliveries. For the purposes of this provision, vehicles making local deliveries shall be defined as vehicles delivering or picking up goods at locations which are situated on or immediately adjacent to the identified highways, roadways and streets.
3. Permits for local delivery may be obtained at Town Hall, Monday through Friday during normal business hours. Permits may be issued on either a daily basis or for the calendar year with approval of the Street Superintendent or Town Marshal.
4. The Street Superintendent is authorized and directed to erect signs specifying the restrictions set forth herein.
5. Nothing herein shall apply to any authorized emergency vehicle (e.g.: fire engine, ambulance, rescue vehicle) as defined in the Indiana Motor Vehicle Code.
6. Penalty, see 71.99

This Ordinance shall be in full force and effect after its adoption and publication as required by law and shall remain in effect thereafter until revoked.





ORDINANCE NO. 762

AN ORDINANCE OF THE TOWN OF OGDEN DUNES, PORTER COUNTY, INDIANA REQUIRING THE PLACEMENT OF ADDRESS NUMERALS UPON STRUCTURES WITHIN THE TOWN.

WHEREAS, the Town of Ogden Dunes Town Marshal and Fire Department have recommended the adoption of this Ordinance to promote the public health, safety and welfare of the residents, citizens, people, and property owners of the Town of Ogden Dunes; and,

WHEREAS, the Ogden Dunes Town Council has studied the matter and now concurs in the recommendation.

NOW THEREFORE, BE IT AND IT IS HEREBY ORDAINED by the Town Council of the Town of Ogden Dunes, Porter County, Indiana, as follows:


1. Every owner or occupant of each house, business, or other structure within the Town of Ogden Dunes, now existing or hereafter erected shall place on such structure or near the street in front of the structure, numerals (Arabic numerals; not Roman numerals or written words) not less than four inches (4") high showing the number of the address of each such structure as assigned by the Town.
2. Numerals shall be placed on the structure or near the street in front of the structure or adjacent to the driveway so that they are visible from the street and shall contrast with the color of the background upon which they are placed.
3. Penalty, see 71.99

This Ordinance shall be in full force and effect after its adoption and publication as required by law and shall remain in effect thereafter until revoked.


